Contractors may include, but are not limited to social workers, counselors, dance instructors, gymnastic or sports instructors, computer instructors, speech therapists, licensed health care professionals, art instructors, statecertified teachers employed through a local school board, and other outside contractors. A person shall not be deemed a contractor if he/she is a staff person of the child-placing agency.
